- Application and payments must be received in full (except for insurance). If you are accepted, you will be notified and your checks will be cashed. If not, your checks will be returned.
- No menu duplication with other vendors. You may sell different types of your item (different flavors, etc.). We will work with each food vendor to create your own unique menu. No sales of any goods other than food. No large signage. Please use chalkboards or small signs. Electricity will be available. BYO cords.

- Return **Health Dept. form (pages 7–10) & fee; or a copy of your annual permit plus page 10 of Health Permit** with this application. Download the City of Berkeley Health Dept. application on the ABS website. Then mail it to Another Bullwinkel Show with this application and separate check. Berkeley is a separate Health Dept. from the County of Alameda and has its own permits.
- Submit a valid **CA Sellers Permit** number with this application. It may be obtained by calling the State Board of Equalization 510.622.4100. You are responsible for collecting and reporting all sales tax. Use reporting address as 1800 Fourth St., Berkeley, CA 94710.
- Begin set up after 2PM to be open for business at 5PM. Booth must remain open until 9PM. The street is reopened at 11PM.
- Restricted:
 - No sales of alcohol.
 - No Styrofoam is allowed in Berkeley.
 - No plastic or non-biodegradable products – no plastic straws or lids.
 - No generators.
- Provide your own water, ice, garbage can, fire extinguisher, electrical cords, lights, etc.
- In case of extremely bad weather or a natural disaster the show may be canceled at the discretion of the Producer. Call 510.548.5335 for recorded information that morning. No refunds or payments will be made if show is canceled.
