• *Tickets will be sold online and at the event for chocolate items available in the restaurants only, not at your booths. Food vendors do not take event menu tickets – your sales are your own, unless you would like to put a chocolate item on the event menu and receive 50¢ for each \$1 ticket collected.

• Include payment with application.

• **Food sales are limited to:**

- Open Booth or Truck: 4 type items + 1 drink + soda/water
- Pre-packaged: 1 type item

This is to avoid menu duplication with other vendors. You may sell different types of your item (different flavors, etc.). We will work with each food vendor to create your own unique menu. Water or soda sales are OK and will not count toward an item, however, other drinks will count toward an item. No sales of any goods other than food.

• If you have open food products a **Certificate of Insurance** worth two million dollars and naming “Another Bullwinkle Show & the North Shattuck Association and its members, directors, employees, agents,

subcontractors, representatives, attorneys, brokers, insurers, lenders, officers, directors, partners, successors (collectively "Producers")" as additional insureds must be emailed to promoter by you or your agent no later than August 1.

- Download the City of Berkeley Health Dept. application on the ABS website. Return **Health Dept. form (p. 7-10) or copy of annual permit + page 10 of Health Permit** with this application to Tante's. Berkeley is a separate Health Dept. from the County of Alameda and has its own permits. Health Dept. fee is included in your booth fee.
- The Health Dept. requires you to have an enclosed, screened food booth or an enclosed vending machine/cart/truck. All food-related booths must have a fireproof tarp on the ground beneath their booth area and weights for the wind. No rentals are provided.
- Submit a valid **CA Sellers Permit** number with this application. It may be obtained from <https://www.cdtfa.ca.gov/taxes-and-fees/sutprograms.htm>. You are responsible for collecting and reporting all sales tax. Use reporting address as 1400 Shattuck Ave., Berkeley, CA 94709.
- Parking: You may be able to parallel park behind your booth in a single parking space (no large trucks). Other parking is available in the neighborhoods.
- Begin set up after 7:45 a.m. to be open for business at 10 a.m. Booth must remain open until 5 p.m. The street is reopened at 6:30 p.m.
- Restricted:
 - No sales of alcohol. No drinking in booths.
 - No Styrofoam is allowed in Berkeley.
 - No plastic or non-biodegradable products – no plastic straws or lids.
 - No loud generators. (Quiet generators like the Honda EU 3000, are OK.)
- Provide your own chairs, booth, ice, garbage can, etc. **There is no electricity available.** CVS and Safeway have ice for sale nearby. Remove your own waste from event booth area.
- In case of extremely bad weather or a natural disaster the event may be canceled at the discretion of the Producer. Call Jacob 510-261-6862 for day of event information. No refunds or payments will be made if show is canceled.
