- Application and payments must be received in full (except for insurance). If you are accepted, you will be notified and your checks will be cashed. If you are not accepted, your checks will be returned.
- Acceptable are handmade arts & crafts or fine arts by maker; highly desired are commercially produced chocolate-related items (crafts, T-shirts, cookbooks, etc.). If you have chocolate or any other type of food, please use the food vendor application. Commercial vendors are welcome and will be screened for acceptance. No sharing of booth spaces.
- Submit a valid **CA Sellers Permit** number with this application. It may be obtained by calling the State Board of Equalization 510.622.4100. You are responsible for collecting and reporting all sales tax. Use reporting address as 1400 Shattuck Ave., Berkeley, CA 94709.
- Submit **several photos** of your items for sale and 1 of your booth, or a website link (unless you have worked with ABS in the recent past). The photos should be representative of that to be sold in your booth.
- Parking: You may be able to parallel park behind your booth in a small car space (no trucks). Other parking is available in the neighborhoods.

- Begin set up after 8:00 a.m. to be open for business at 10 a.m. Booths must remain open until 5 p.m. The street is reopened at 6:30 p.m.

- Restricted:

- No sharing of booths.

- No Styrofoam is allowed in Berkeley.

- No fireworks, snap pops, silly string, sparklers, tobacco, taser sales or give-aways.

- No food, candy or water sales or give-aways unless you are a food vendor.

- No clipboard activity outside of your booth.

- No loud generators. (Quiet generators like the Honda EU 3000 are OK.)

- **Green Event:** Remove all plastic packaging from merchandise prior to sale.

- Provide your own chairs, booth, ice, garbage can, etc. Water is available. There is no electricity available, BYO QUIET generator. CVS and Safeway have ice for sale nearby.

- In case of extremely bad weather or a natural disaster the show may be canceled at the discretion of the Producer. Call 510.548.5335 for recorded information that morning. No refunds or payments will be made if show is canceled.
