Independent Business	Sole proprietor. Items purchased by you for resale including imports, manufactured items from your designs, kits, commercial reproductions, taped music, etc. are acceptable. Services OK.
Corporate Business	Partnership/Corporation/LLC/LP, etc.

- The event is on Shattuck Ave. on the frontage road between Rose and Vine Streets in Berkeley from 10AM–3PM. Please dress you and your booth in holiday garb. No Scrooges! The snow will be 'blown' in 7:30–9AM. It is quite something to watch! Your booth should stay open 10AM–3PM.

- For same day sign up register after 8:30AM at the HQ tent in front of CVS on the sidewalk. Park in the CVS lot ONLY while you register. After you register you will be given a parking permit for your dashboard so you may move your car into the proper spot.

- Free admission. Crowd estimates 3,000 – many are families with young children.

- Interactive art projects are encouraged. You may charge the public for your project. Deduct \$25 from the cost of the booth fee.

- Submit a valid **CA Sellers Permit** number with your application if you are selling anything. It may be obtained from <https://www.cdtfa.ca.gov/taxes-and-fees/sutprograms.htm>. You are responsible for collecting and reporting all sales tax. Use reporting address as 1450 Shattuck Ave., Berkeley, CA 94709.
- After receiving your application and fees, promoter will assign you a 10'x10' space. Booths are on pavement.
- Free parking is on the outside of the median, behind the row of vendor booths, first come–first served, so you may be able to park right behind your booth; if not, then not too far away. We have reserved those spots for vendors until you are all parked and then will open any remaining for the public. There is FREE Sunday street parking everywhere in the neighborhood. Do not park in the CVS lot after 9AM.
- Begin set up 8AM to be open for business 10AM–3PM. (A big plus is that you get to 'watch it snow' during set up!)
- Provide your own chairs, booth, holiday decorations, garbage can, etc. **There is no electricity available.** BYO quiet generator if needed. A back wall to your booth and weights are highly recommended.
- Restricted:
 - No sharing of booths.
 - No Styrofoam is allowed in Berkeley.
 - No sales or giveaways of fireworks, snap pops, silly string, sparklers, tobacco, or tasers.
 - No sales or giveaways food, candy or water unless you are a food vendor. Use the food vendor application.
 - No clipboard activity outside of your booth.
 - No loud generators. (Quiet generators like the Honda EU 3000 are OK.)
 - **Green Event:** Remove all plastic packaging from merchandise prior to sale, unless you have pre-packaged food items.
- In case of extremely bad weather or a natural disaster the event may be held the following Sunday. Call 510.548.5335 for recorded information that morning. No refunds or payments will be made if show is postponed or canceled completely.
