- This is the Persian celebration of the arrival of spring when everyone lines up to jump over bonfires in the street and dances their way into the new year. Persian techno music & dancing with DJ Dr. T, delicious Persian food, crafts, and children's activities add to the experience in this free, evening outdoor event. Sponsored by the Persian Center of Berkeley. Expected attendance is 5,000. This is an affluent group of families who come for dinner.

- A **Certificate of Insurance** worth one million dollars and naming "Another Bullwinkle Show & the Persian Center and its members, directors, employees, agents, subcontractors, representatives, attorneys, brokers, insurers, lenders, officers, directors, partners, successors (collectively "Producers")" as additional insureds must be mailed with this application or sent to promoter by you or your agent no later than March 1.

- Return **Health Dept. Forms & Fees** to promoter with this application. City of Berkeley Health Dept. fees are \$182 open food/\$44-\$98 pre-packaged (see their site for variations on this). The Health Dept. requires you to have an enclosed food booth or an enclosed vending machine/cart. Download the Berkeley application on the ABS website. Contact Another Bullwinkle Show first for instructions on how to submit these forms and checks if you are not clear.

- Submit a valid **CA Sellers Permit** number with this application. It may be obtained by calling the State Board of Equalization 510-622-4100. You are responsible for collecting and reporting all sales tax. The event address for reporting purposes is 2029 Durant Ave., Berkeley, CA, 94704.

- After receiving your application and fees, promoter will assign you the above 10' deep space for vendors which will be located on the street. All BBQs must locate to the side of enclosed booth and be roped off from the public. Pre-packaged booths are 10'x10' and will be placed with other vendors in another location. You may park in a free lot nearby.

- Begin set up after 3 p.m. to be open for business at 6 p.m. Booths remain open until 10:00 p.m. The street is reopened about 11 p.m.

- No sales of alcohol – alcohol-free event. No Styrofoam is allowed in Berkeley. No sales of any goods other than food. Please provide recyclable or biodegradable greenware, paper plates and cups, wooden stirrers, etc. Do not use plastic or non-biodegradable products if possible.

- Provide your own chairs, tables, booth, white string lights, ice, a container for disposal of barbecue coals, a garbage can. Minimal electricity is available for food booths – two outlets per booth. BYO 75' long extension cords. Best to BYO quiet generator, however, if you have one.

- In case of extremely bad weather or a natural disaster the show may be canceled at the discretion of the Producer. Call 510.548.5335 for recorded information that morning. No refunds or payments will be made if show is canceled.
