Independent Business	Sole proprietor. Items purchased by you for resale including imports, manufactured items from your designs, kits, commercial reproductions, taped music, etc. are acceptable. Services OK.
Corporate Business	Partnership/Corporation/LLC/LP, etc.

- This is the Persian celebration of the arrival of spring when everyone jumps over bonfires in the street and dances their way into the new year. Persian techno music & dancing, Persian food, crafts, and children's activities add to the experience in this free, evening, outdoor, non-alcoholic event. Sponsored by the Persian Center of Berkeley. Expected attendance is 6,000. This is an affluent family crowd.
- Booth size is 10' x 10.' No sharing of spaces. Approx. 30 spaces are available in one location in the street. You provide booth/canopy, chairs, lights, 75' extension cord, & garbage can. You must accept the designated space provided by the Producer. Electricity is available. Bring small white string lights to decorate your tent.
- **Restricted:** No animals, Styrofoam, alcohol, or glow-in-the dark items. **You may not sell or give away food, candy, water, or drinks.** Alcohol-free event. Activity must take place within your booth - no 'clipboard' activity or pitches outside of your booth.
- Arts, crafts, fine art, non-profit, & commercial vendors are all welcome. There is no jurying but your wares should be relevant to this specific community in some way, although others may be accepted at the discretion of the Persian Center Board of Directors.

- Submit your website or several photographs of your work and one photo of your booth if available, unless you have worked with ABS recently. The photos must be representative of that to be sold in your booth. Discrepancies may result in expulsion at the event.
- Submit your valid **CA Sellers Permit number** on this application. Temporary numbers may be obtained from <https://www.cdtfa.ca.gov/taxes-and-fees/sutprograms.htm>. You are responsible for collecting and reporting sales tax. The address for reporting taxes is 2029 Durant Ave., Berkeley, CA, 94704.
- Begin set up after 3 p.m. (not before) to be open for business at 6 p.m. Booths shut down at 10 p.m. The street reopens about 11 p.m. Free parking lot for your vehicles is nearby but not at your booth. Bring a hand truck!
- Show is held rain or shine. However, in case of extremely bad weather or a natural disaster the show may be canceled at the discretion of the Producer. Call 510.548.5335 for recorded information that morning. No refunds or payments will be made if show is canceled.
